General Information

All persons entering upon Club grounds assume the risks associated with the Covid 19 pandemic and are required to take appropriate measures to protect themselves and others. This includes full compliance with the following guidelines.

These guidelines will stay in effect until further written notice and non-compliance may result in disciplinary action.

Member and Operational Guidelines

If you have ANY symptoms that could be related to the Coronavirus or if you think you have been exposed to someone who has the virus; DO NOT come to the club!

If you are a vulnerable individual by age group or if you have underlying medical conditions, please give careful consideration before visiting the club.

While you are at the club, please do the following:

- Follow social distancing guidelines, keep at least six feet away from others.
- Wearing of masks or other garments that cover the nose and mouth is required while on club property except while eating or drinking, while in a vehicle alone or with members of your immediate family or while on a shooting station preparing to shoot or shooting.
- Clubhouse occupancy is limited to those chairs and tables located by management. Restroom use and cashiering functions are also permitted. Please observe queues and spacing designations.
- Please use credit/debit cards for payment of regular club items. Cash should be the payment of last resort. This does not apply to event entry fees.
- While at the club, frequently wash/disinfect your hands according to CDC guidelines.

If you are shooting a break open shotgun, please pocket your empties and discard them appropriately.

Bring your own food. Food will not be ordered. Self serve coffee will be available as well as vending drinks.

Personal disinfectant wipes and hand sanitizer can only add to protection.

When filling your shooting card please add enough targets for the next couple of months to minimize visits to the cashier.

Clubhouse porch may be used but social distancing is required.

Shooting groups will be limited to 5 individuals. Individuals in these shooting groups must maintain proper social distancing of at least 6 feet.

When at the gun racks or waiting to shoot on skeet, trap or 5 stand fields individuals must maintain proper social distancing of at least 6 feet.

When shooting sporting clays, do not approach the next station until the individual or group in front of you is finished and is well down the path.

Clipboards and other scoring material will not be available.

Club motorized golf cars are available.

Club push carts will be available and must be returned to the clubhouse at completion of use for sanitization.

All touch surfaces will be sanitized regularly.

Station buttons will be sanitized regularly.

Hand sanitizer will be accessible.

Field availability and hours of operation as normal.

Employee Guidelines

If you have ANY symptoms that could be related to the Coronavirus or if you believe that you were exposed to anyone who has the virus; do not come to work.

Follow social distancing guidelines.

Wash/disinfect your hands often.

All staff must wear face coverings while on the property.

Disinfection Procedures:

- Prior to opening and regularly during the day or as conditions warrant; disinfect all, counters, door handles, railings, touch points in rest rooms, etc.
- Wipe down the cage area, credit card terminal and related computer equipment with disinfectant at frequent intervals.
- Prior to opening, disinfect portable equipment utilized by members. That includes 5-Stand controllers, skeet solo controllers, push carts touch points, etc. Immediately upon return, the aforementioned items are to be disinfected. Club guns loaned to members need to be wiped down prior to issuance and wiped down again upon return.
- Prior to opening, disinfect all Long Range control units and release cord buttons. On Trap fields, disinfect microphone touch points. Additional disinfecting wipe downs will be done periodically as activity warrants.
